

VALLEJO INTER-TRIBAL COUNCIL 2010 Pow Wow

TERMS OF AGREEMENT

- 1.) The Vallejo Inter-Tribal Council, hereafter referred to as Event Host and _____ hereafter referred to as Event Vendor do enter into agreement of mutual benefit.
- 2.) That the Event Host intends to hold a public event in the City of Vallejo, County of Solano, California, and the Event Vendor wishes to rent booth space for the purpose of retail business at this event.
- 3.) The Event Vendor agrees:
- a. that no circulation of petitions, flyers, announcements or advertisements will be allowed without express, written permission from the Board of Directors governing the Event Host.
 - b. that the Event Vendor will provide at their cost sufficient Liability Insurance, either with (1) - a copy of their existing insurance policy naming the Event Host and the City of Vallejo as covered or (2) - by submitting the amount of \$50.00 to the Event Host prior to 1 MAY 2010.
 - c. that the Event Vendor will solely occupy the booth space provided at the event and that no third party will conduct business at the planned event.
 - d. that, providing item b.(2) has been satisfied, a late fee of \$50.00 shall be assessed to the registration fees after 1 JULY 2010.
 - e. that all spaces are assigned on a first come/first served basis. All booth assignments are final. No exceptions.
 - f. to conduct business in accordance with all applicable state, county and city laws and regulations. Any criminal activity will immediately result in expulsion from the event and notification of law enforcement officials.
 - g. that the Event Vendor will take every precaution to safeguard public property on which the event is held and that the Event Vendor may be held responsible for damage caused.
 - h. that no water or electrical services will be available for use at the event site.
 - i. that the Event Vendor will offer only authentic Native American made merchandise.
 - j. that the Event Vendor shall post no sign for display or announcements such as "FOR SALE".
 - k. that the Event Vendor will not sell any Sacred item including the following items:

Eagle feathers	Pipestone	Sage
Cedar	Sweetgrass	Sacred Medicines
 - l. that the Event Host shall provide for the general safety, security and loss prevention with unarmed patrols on the event site from: **12 NOON FRIDAY, JULY 23, 2010 until 6 PM SUNDAY, JULY 25, 2010**. However, the Event Vendor has the ultimate responsibility for security and loss prevention of Vendor property, and will save harmless the Event Host and it's agents from any loss or damage of property.
 - m. that the Event Vendor will immediately report to the Registration Booth prior to unloading and set-up.
 - n. that the Pow Wow is a spiritual celebration and will conduct themselves accordingly.
 - o. that this event is a two (2) day commitment.
 - p. that security personnel represent the Event Host and are the authority of enforcement in this contract.

4.) The Event Host agrees:

a. Provide the Event Vendor with retail space as follows:

- > **Booth Space, Single** 12'x12' w/ 1 vehicle space ____ space(s) @ \$ 250.00 ea. = \$ _____
- > **Booth Space, Double** 12'x24' w/ 2 vehicle space ____ space(s) @ \$ 500.00 ea. = \$ _____
- > **Liability Insurance** for the duration of the event DUE 1 MAY 2010 \$ 50.00 = \$ _____
- > **LATE FEES** assessed after 1 JULY 2010 \$ 50.00 = \$ _____
- > **Business License** \$ 25.00 = \$ _____
- > **TOTAL AMOUNT** submitted with application to: VALLEJO INTER-TRIBAL COUNCIL \$ _____
